The float for May Daze was done using a \$500 cheque written to himself, cashed and then re-deposited. Jonathan suggested giving John an expense account, but he would rather not, for the sake of being transparent. John prefers to keep track of his expenses for the year and be reimbursed as a lump sum.
